

Material Availability



We provide three modes of transportation



Truck Delivery is for customers who are located in the same country with our warehouse.



Customer self-pick up is for customer who would like to pick up product from our warehouse. Our warehouses are located at Kobe, Kawasaki and Kashima.



Port sales is where products are imported from overseas plants to Japan ports. Customers can pick up product at Japan port or we can deliver product to your in-land destination.

Did you know?

It is important for you to verify the details in Order Confirmation or Customer Service's confirmation email against your Purchasing Order and reply back to Customer Service if any discrepancies found.

Did you know?

- For customers with prepayment arrangements, your order will be processed upon receipt of the payment slip within the cutoff time.
- For L/C customers, your order will be processed upon receipt of the clean L/C



How will I be billed?

We provide collective invoice in electronic copy on monthly basis by beginning of following month.

How do I change/ cancel my order?

For truck deliveries, you may request order changes or cancellation as long as it is within the total lead time shown in Page 7.

For customer self-pick up arrangement, order change or cancellation can be done 1 working day before pick up date if request is receive before order cut-off time.

For Port Sales, you may request for order changes or cancellation as long as the order has not been confirmed or booked.

How can I pay my bill?

Bank of America (Tokyo branch) is our main service bank for JPY currency. Payment method is **Telegraphic Transfer (T/T) :** Please provide our company your invoice number when remitting the payment for our reference. For prepayment, please provide your bank slip to our Customer Service for further processing.



Flatbed truck not recommended



Please be informed that using of Flatbed truck (平板车) is not recommended to load product from our warehouse due to security concern and it is prone to have product quality issue. Recommended truck type is high barrier truck and shall have properly cover, this is to prevent product topple and wet packaging.

Lease Crate Collection

All Butyl and some EPDM products are supplied in leased crate which must be returned to the crate providers; GPS and Goodpack.

Once product registration is completed, in case the product packaging is leased crate, our customer service will provide you with the detailed guideline on leased crate handling.

Please follow the detailed guideline when preparing to return the leased crate and inform crate providers' local contacts and our customer service team to arrange the pick-up when it is ready for collection.

Product from Kawasaki and Kashima Warehouse

The crate provider is Goodpack. The collection will be arranged by Japan Butyl. Please contact our customer service to arrange the crate collection by providing below information.

Product from Kobe Warehouse

The crate provider is GPS. The collection will be arranged by GPS Japan. Please contact GPS Japan (contact information is provided in GPS crate handling detailed guideline) and keep our customer service team in the email loop to escalate when there is an urgent case. Please provide below information.

Lease Crate Collection

Why leased metal crate?

- Reusable, leased metal crates free up the one-way packaging disposal
- Reduce packaging waste and ensure sustainability
- No contamination risks
- Better efficiency, rubber bales easily removable since crate's four sides fold down to the ground or can be stripped off

Who is our crate vendor?





What to aware?

- Please follow crate vendor's handbook for more details
- Crates from different vendors are not stackable and will create damage

Rental time **stops** once contact vendor to collect

- Customer to ensure crate condition before usage due to unforeseen incidences during transit and/ or storage
- Detailed CFB is required for every rejection or Issue for further investigation
